



This is in response to your September 9, 2009, inquiry with the Florida Public Service Commission (PSC) regarding Florida Power & Light Company (FPL).

On September 9, 2002, the PSC issued Order No. PSC-02-1226-FOF-EI, in which the Commission determined that we will no longer receive or process any complaints regarding any industry regulated by this Commission that involve you or others, filing on your behalf. We will receive and process your complaint ONLY if you submit your complaint in writing, and have it signed by a member of the Florida Bar, in good standing, indicating the attorney's Florida Bar number and the attorney certifies that the complaint is not frivolous. Further, the Commission granted staff administrative authority to close any future complaints involving you that fail to meet the criteria without further action of this Commission. I have enclosed a copy of the order for your review.

We have cancelled complaint 886290E because you did not meet the filing requirements outlined in Order No. PSC-02-1226-FOF-EI.
