
Per the above referenced order, please accept this submittal as a status report regarding the FDEP Consent Order, to construct centralized treatment prior to January 30, 2010.

As referenced in the previous status report dated July 17, 2009. The Utility has explored alternatives to the construction of centralized treatment including the sale of the Utility to the FGUA wherein water would be purchased from the Pasco County system. Negotiations and due diligence towards the sale are now complete. Closing will occur concurrent with the closing of the Lindrick Utility Systems which is also being purchased by the FGUA. A closing date has not been set at this time.

Construction of the Centralized treatment System is on hold at this time. The Utility is fully compliant with current water quality standards and with the terms of the FDEP Consent Order and has met with FDEP to request an extension of the compliance date from January 2010 to July 2010.
