Mrs. McCoy-Earnhart,

It was a pleasure speaking with you yesterday. Per my telephone conversation with 8 Communications LLC, the planned rollout of prepaid products in Florida has been unexpectedly delayed.

Therefore, the company wishes to have a post January 1, 2010 effective date, as offered by the FL PSC. The company will still rollout its retail products in Florida but slightly later than expected.

This is to avoid the company incurring the minimum \$700 annual IXC RAF regulatory fee in January 31 on Fiscal Year 2008 revenues, in light of the fact that it does not yet have such retail FL revenues.
