

On November 12, 2009, T-Mobile filed a petition requesting designation as an Eligible Telecommunications Carrier (ETC) in the rural areas of CenturyLink, Frontier, Indiantown, NEFCOM, TDS, Smart City, and Windstream in order to be eligible to receive high-cost and low-income federal universal service support.
