**AT&T FLORIDA'S NOTICE OF WITHDRAWAL OF ITS
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION FOR
EXHIBIT CAC-2**

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), by and through its undersigned counsel, respectfully files this notice withdrawing its Request for Specified Confidential Classification ("RCC") for Exhibit CAC-2 to Cindy Clark's Direct Testimony and states the following:

1. On October 7, 2009, AT&T Florida filed a Notice of Intent to Request Specified Confidential Classification for Exhibit No. CAC-2 (produced on CD only) to Cindy Clark's Direct Testimony which contained information that, upon information and belief, was considered confidential business information to DSLi Internet Corporation d/b/a DSLI ("DSLi").

2. In that regard, on October 28, 2009, AT&T Florida also filed an RCC for Exhibit No. CAC-2 to Cindy Clark's Direct Testimony.

3. Upon review of the Direct Testimony of Eduardo Maldonado, DSLi attached a copy of the document to Mr. Maldonado's Direct Testimony as Exhibit No. EM-10, which was filed publicly with the Commission. Moreover, DSLi indicates in Mr. Maldonado's Rebuttal Testimony at page 3 that Exhibit No. CAC-2 is an electronic version of Exhibit No. EM-10.

4. Accordingly, based upon the foregoing, AT&T Florida withdraws its RCC dated October 28, 2009 for Exhibit No. CAC-2 to Cindy Clark's Direct Testimony.
