25-6.0424: Petition for Mid-Course Correction

PURPOSE AND EFFECT: Rule 25-6.0424 would be created in order to codify existing Commission procedure for filing a petition for mid-course correction to fuel cost recovery or capacity cost recovery factors. Undocketed.

SUBJECT AREA TO BE ADDRESSED: Investor-owned electric utility regulation.
