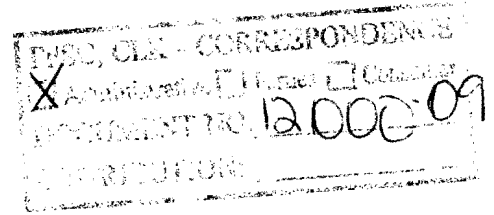

### Case Background

On December 11, 2009, Progress Energy Florida, Inc. (PEF) filed a petition requesting approval of an amendment to a negotiated contract for firm capacity and energy between BG&E of Florida, LLC (BG&E) and PEF dated November 25, 2009.
