On behalf of Progress Energy Florida, Inc. ("PEF") and Withlacoochee River Electric Cooperative, Inc. ("WREC"), the parties wish to provide additional information to the above stated petition. The joint petition speaks to boundary modification in four areas to resolve outstanding issues between WREC and PEF.

WREC provided notification letters to their customers in Pasco and Hernando counties informing the customers that their account would not be transferred to PEF from WREC due to operational constraints, acquisition of easements, space for utility locations and safety issues, as outlined in the attachment. The customers receiving this notification letter of non-transfer are located on Coats Road, Linwood Lane, and Ryals Road in Zephyrhills, Pasco County, Florida. You have received at least one notification that your account was to be transferred from Withlacoochee River Electric Cooperative (WREC) to Progress Energy Florida (PEF). Those transfers were to have taken place earlier this year. WREC and PEF have mutually agreed **NOT** to make that transition.

Operational constraints, including the acquisition of easements that would allow building new lines were major reasons for the decision. Available space for utility locations in your area is very limited. Another related issue was safety; both public and for the employees of each power company that would have to construct and maintain the high voltage lines and equipment.
