Prime Time Communications, Inc has sent in a certificate of withdrawal to the Florida Dept. of State for December 31, 2009. I would like to request cancellation of our registration and/or certificate.

We do not have any customer deposits. We always bill our customers for the month at the start of the next month; so their final bills will be sent the first week of January 2010. If there is a regulatory assessment due, we will pay it by its due date. Unfortunately, we have to cancel with Florida because we have always been a small reseller there, but your fees have increased from \$50 to \$700 per year. Our company cannot afford this. This is a hardship on small businesses; but not large ones. However, this is the FL PSC's rule, so I have no other option.
