RE: **Docket No. 090517-TP** - Request for cancellation of CLEC Certificate Nos. 8326, 5228, 7759, and 4861, held by Cleartel Telecommunications, Inc. d/b/a Now Communications, also d/b/a VeraNet Solutions; IDS Telcom Corp. d/b/a Cleartel Communications; nii Communications, Ltd.; and Supra Telecommunications and Information Systems, Inc., respectively, and for acknowledgment of cancellation of IXC Registration Nos. TJ777, TJ987, TJ510, and TK091, held by Cleartel, IDS, nii communications, Ltd., and Supra, respectively, effective November 25, 2009.

Cleartel Telecommunications, Inc. d/b/a Now Communications, also d/b/a VeraNet Solutions; IDS Telcom Corp. d/b/a Cleartel Communications; nii communications, Ltd.; and Supra Telecommunications and Information Systems, Inc. have requested cancellation of their IXC tariffs and Registration Nos. TJ777, TJ987, TJ510, and TK091, respectively, effective November 25, 2009.

The companies complied with the provisions of Rule 25-24.474(2), Florida Administrative Code, by providing adequate notice in writing of their requests for cancellation and paying the 2009 Regulatory Assessment Fee, as required in Section 364.336, Florida Statutes. If a company commences operations in Florida as an intrastate interexchange carrier in the future, a new registration must be filed.

Pursuant to Section 2.07.C.5.i, Administrative Procedures Manuel, the holders of IXC Registration Nos. TJ777, TJ987, TJ510, and TK091 can be removed from the IXC Registration list effective November 25, 2009.

The companies also requested cancellation of their CLEC certificates which is being handled separately. According, with this Memorandum, Docket No. 090517-TP should remain open pending issuance of a Consummating Order addressing the CLEC cancellations.
