Dear Ms. Cole:

Docket No. 080271-EI was opened to monitor the status of joint ownership discussions associated with Florida Power & Light's ("FPL's") Turkey Point Units 6 & 7, as directed in Order No. PSC-08-0237-FOF-EI.

By Order No. PSC-08-0237-FOF-EI, the Commission approved a stipulation which states in relevant part: "No later than July 1, 2009, FPL will continue its good faith discussions with FMEA, FMPA, and OUC, and will also commence good faith discussions of joint participation in Turkey Point Units 6 & 7 with JEA and Seminole. FPL will report the status of such ongoing status discussions to the FPSC every quarter thereafter."

As required by Order No. PSC-08-0237-FOF-EI, FPL has continued good faith discussions with FMEA, FMPA, and OUC, JEA and Seminole.

FPL filed its first quarterly Report on Joint Ownership Discussions on September 24, 2009. That report stated that two separate meetings had been conducted with potential Joint Owners, one on August 25, 2008 and another on April 27, 2009. During the last meeting, the participants agreed that the next meeting will be held in late 2009 or early 2010. That next meeting has not yet occurred. FPL will update the Commission on its next meeting and any subsequent meetings in future quarterly reports.
