NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELING ALTERNATIVE ACCESS VENDOR CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Gulf Long Distance, Inc. (Gulf), holder of Alternative Access Vendor (AAV) Certificate of Public Convenience and Necessity No. 4063, has requested the cancellation of AAV Certificate No. 4063. Gulf has complied with the provision of Rule 25-24.735(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its AAV certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2009. Accordingly, we find it appropriate to cancel AAV Certificate No. 4063, effective December 9, 2009. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Gulf Long Distance, Inc.'s Certificate No. 4063 to provide Alternative Access Vendor services is hereby canceled, effective December 9, 2009. It is further
