Staff has requested that the Utility provide a cost justification for the Utility's requested miscellaneous service charges.

The Utility is requesting miscellaneous service charges of \$27.00 during business hours, and \$40.00 after hours for Initial Connection and Normal Reconnection. Violation Reconnection fees will continue to be charged at actual cost. These charges are consistent with what this Commission has recently approved for other wastewater utilities. The Public Service Commission, in Docket Nos.: 080249-WS and 080250-SU, has recently authorized other wastewater utilities to implement similar miscellaneous service charges. A calculation of the costs comprising those fees is as follows:


