On March 4, 2010, Florida Power & Light Company ("FPL") filed a Request for Confidential Classification of certain information provided in response to the Staff of the Public Service Commission's First Set of Interrogatories (Nos. 1 and 8) and First Request for Production of Documents (Nos. 2, 4, and 5).
