On behalf of Comcast Phone of Florida, LLC ("Comcast") and CIMCO Communications, Inc. ("Cimco"), I am writing to notify you that the Federal Communications Commission has approved Comcast's acquisition of the assets of Cimco. *See Applications Filed for the Acquisition of Certain Assets of CIMCO Communications, Inc. by Comcast Phone LLC, Comcast Phone of Michigan, LLC and Comcast Business Communications, LLC*, WC Docket No. 09-183, Memorandum Opinion and Order and Order on Reconsideration, FCC 10-41 (rel. Mar. 15, 2010). The transaction closed on March 16, 2010. All customers have been transferred to Comcast in accordance with applicable migration guidelines.

Cimco will separately request cancellation of its local exchange authorization and interexchange registration. Where applicable or necessary, Comcast will revise its tariff and price list.
