This type of proprietary confidential business information is not made public. Disclosure would impair the provider's competitive interests.
- 4. Table 1 Attachment A: The information provided in Table 1 consists of competitively sensitive information related to the number and location of tw telecom's access lines. Such information is considered by tw telecom to be proprietary confidential business information. Disclosure would impair the provider's competitive interests.
