

Pursuant to the requirements in this docket, FPUC, concurrently with the filing of this petition, files testimony and PGA Schedule A-7 (Exhibit JVMJ-1) for the period of January 2009 through December 2009, consisting of the purchased gas adjustment true-up reporting form supplied by the Commission Staff.
4. As indicated in the testimony of Mr. James V. Mesite, Jr., FPUC’s final true-up amount for the period January 2009 through December 2009, including interest, net of the estimated true-up for the same period, is a under-recovery of \$390,798. This reflects the difference

between the Company's actual over-recovery of \$2,127,921.56 for the period as compared to its estimated over-recovery of \$2,518,720.

WHEREFORE, FPUC respectfully requests that the Commission enter its Order approving the Company's true-up amount for the period January 1, 2009 through December 31, 2009.


