RULE NO: RULE TITLE

25-22.0406: Notice and Public Information on General Rate Increase Requests by Electric, Gas and Telephone Companies

PURPOSE AND EFFECT: To amend Rule 25-22.0406 to address notice and public information requirements for electric and gas utilities filing petitions for limited proceeding and to delete references to telephone companies. Undocketed.

SUBJECT AREA TO BE ADDRESSED: This rulemaking will address notice and public information requirements for electric and gas utility companies filing petitions for limited proceedings and for telephone companies filing requests for general rate increase.
