STAFF DATA REQUEST NO. 1

**Re: Docket No. 100186-EG, Petition for approval of natural gas residential energy conservation programs, by Associated Gas Distributors of Florida.**

Dear Mr. Horton:

By this letter, the Commission staff requests that Associated Gas Distributors of Florida provide responses to the following data requests.

1. Please provide a chart showing, by LDC, the annual impact on customers' monthly bills for the proposed modifications to residential gas energy conservation programs.
2. Please provide a chart showing, by LDC, the amount recovered each year from the Energy Conservation Cost Recovery proceedings from 2006 through 2010.
3. Paragraph 16 of the petition discusses a program advocating replacement of electric appliances with gas appliances. Paragraph 17 discusses advocating retention of existing gas appliances. Meanwhile, Rule 25-17.015 (5), Florida Administrative Code, states, "Advertising expense recovered through energy conservation cost recovery shall be directly related to an approved conservation program, shall not mention a competing energy source, and shall not be company image enhancing." Please provide an explanation of how the LDCs intend to assure the Commission they are in compliance with the cost recovery rule pertaining to mention of a competing energy source when advertising the programs discussed in paragraphs 16 and 17 of the petition.
