Customers will be given the opportunity to present testimony at the beginning of the morning session on Wednesday, July 7, 2010. Additionally, an evening session will be held beginning at 6:00 p.m., July 7, 2010, for the purpose of the hearing testimony from customers who were unable to attend the prior session.

All customers who wish to testify are urged to be present at the beginning of the sessions, since the sessions may be adjourned early if no customers are present. By providing customer testimony, a person does not become a party to the proceeding. To become an official party of record, you must file a Petition for Intervention at least five days before the final hearing, pursuant to the requirements contained in Rule 25-22.039, Florida Administrative Code.

PURPOSE

The purpose of this hearing is to consider the application of Skyland Utilities, LLC, for original certificates for proposed water and wastewater systems, in Hernando and Pasco Counties, and request for initial rates and charges. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on June, 28, 2010. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

EMERGENCY CANCELLATION

If a named storm or other disaster requires cancellation of the prehearing conference, Commission staff will attempt to give timely direct notice to the parties. 
JURISDICTION
