**OPC'S REQUEST TO PERMIT ENTRY UPON LAND AND PROPERTY FOR
INSPECTION OF SYSTEM**

Pursuant to § 350.0611(1), Fla. Stat. (2004), Fla. Admin. Code R. 28-106.206, and Fla. R. Civ. P.1.350, the Citizens of the State of Florida, through the Office of Public Counsel ("OPC"), hereby request Water Management Services, Inc. ("WMSI") to permit designated employees and consultants of OPC to enter upon land and property at a mutually convenient time for the purpose of inspecting, measuring, photographing, sampling, or testing the property and facilities owned, leased, employed, or proposed to be acquired by WMSI in connection with the ownership and operation of WMSI's water utility on St. George Island. Such property and facilities include, but are not limited to, water supply wells; the 12" supply main attached to the bridge to the island; the pipeline connecting Well No. 1 to Well No. 4; all pipelines connecting wells to the supply main; the 1,100,000 gpd capacity treatment system on St. George Island; the ground storage tank and the elevated storage tank on St. George Island; property proposed for the relocation of a portion of the 12" supply main; property proposed for the location of proposed new high service pumps and new ground storage tank; existing high service pumps; electrical
