

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), respectfully submits this Response to Request for Oral Argument filed by LifeConnex Telecom, LLC f/k/a Swiftel, LLC ("LifeConnex").

AT&T Florida believes that the parties' pleadings adequately explain the parties' respective positions and that the negotiated interconnection agreement between the parties is clear that LifeConnex is to "make payment to [AT&T Florida] for all services billed **including disputed amounts.**" Thus, AT&T Florida believes that oral argument is not needed. However, to the extent that the Commission grants oral argument, AT&T Florida requests an opportunity to respond to any argument presented by LifeConnex regarding its Request for Emergency Relief.
