RE: 100141-TP Request for approval of interconnection, unbundling, resale, and collocation agreement between BellSouth Telecommunications, Inc. d/b/a AT&T Florida d/b/a AT&T Southeast and American Fiber Systems, Inc.

Dear Mrs. Cole:

On March 24, 2010, BellSouth Telecommunications, Inc. d/b/a AT&T Florida d/b/a AT&T Southeast and American Fiber Systems, Inc. filed an interconnection, unbundling, resale and collocation agreement for Florida Public Service Commission approval. Then on July 7, 2010, BellSouth Telecommunications, Inc. d/b/a AT&T Florida d/b/a AT&T Southeast filed a correction letter styled "Approval of interconnection, unbundling, resale and collocation agreement with six amendments pursuant to Sections 251 and 252 of the Telecommunications Act of 1996." However, the cover letter did not correctly present the subject, and it should be changed.

The initial filing of the interconnection agreement filed on March 24, 2010 in docket 100141-TP, is a duplicate of the agreement filed on March 3, 2003, in docket 030220-TP. However, the six amendments that were attached were new amendments to the existing agreement.

Please use this letter to correctly style the submittal and Docket title as "Request for approval of six amendments to an existing agreement filed in docket 030220-TP and withdrawal of the duplicate interconnection, unbundling, resale and collocation agreement filed on March 24, 2010 in docket 100141-TP, pursuant to Sections 251 and 252 of the Telecommunications Act of 1996."

I would appreciate your assistance in correcting the filing and record in question.
