Progress Energy Florida, Inc. ("PEF" or the "Company"), pursuant to Section 366.093, Fla. Stat., and Rule 25-22.006, F.A.C., files this notice of intent to request confidential classification of the Confidential Direct Testimony of William R. Jacobs, Jr., Ph.D., filed by the Office of Public Counsel in the above docket, bearing Commission Document Numbers 05593-10. This testimony contains confidential and sensitive cost figures regarding the Company's nuclear projects, including contractual cost information and confidential and proprietary contractual terms. Public disclosure of this information would impair PEF's competitive business interests and would also violate confidentiality agreements contained in PEF's contracts with third party vendors.

This information should be accorded confidential treatment pending the filing of PEF's request for confidential classification and a decision on PEF's request by the Florida Public Service Commission.


