

1. On February 16, 2010, Florida City Gas requested confidential classification of certain information including invoices reflecting customer specific information, usage, charges and other details about customer accounts that are of value to competing businesses; usage reports and analyses which provide specific information about customer charges and revenue; contractual information reflecting charges for and amounts paid for supplies; and detailed reports which, if disclosed would reveal customer consumption information which is of value to competitors.


3. The County's Response to PSC Staff's First Set of Interrogatories (Nos. 1-14) includes information that FCG requested to be confidential.
