P-13E [ILPP]: Incomplete LNP Provisioning Process

Definition

Measure the effectiveness end to end LNP provisioning process for all LNP order types that require a 10 digit trigger.

Exclusions

• Service Orders cancelled by CLEC

Business Rules

Capture the number of LNP flow through orders eligible for application of the 10 digit trigger by AT&T, but that don't receive the 10 digit trigger due to provisioning system process errors.

Calculation

LNP Disconnect Performance = $(A / B) \times 100$; $(C / D) \times 100$; $(E / F) \times 100$

- A = Number of LNP flow through orders eligible for application of the 10 digit trigger, but don't have the trigger applied.
- B = Total number of LNP flow though orders eligible for application of the 10 digit trigger during report period.
- C = Number of LNP service order completion notices (SOC) not issued due to an incomplete LNP disconnect process.
 D = Total number of LNP service orders that required a service order completion notices (SOC) sent during the report
- period.
 B = Number of billing completion notices (BCN) not sent as a result of an incomplete LNP disconnect process.
- F = Total number of Billing Completion Notices (BCN) associated with LNP flow through orders sent during report period.
