The purpose of the hearing is to permit parties to present testimony and exhibits relative to DeltaCom, Inc.'s Petition regarding liability for access charges, and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony on the issues identified by the parties at the prehearing conference held on Monday, August 30, 2010.
