Docket No. 100288-TL – Petition of Quincy Telephone Company d/b/a TDS Telecom/Quincy, Smart City Telecommunications LLC d/b/a Smart City Telecom, GTC, Inc. d/b/a Fairpoint Communications, Northeast Florida Telephone Company d/b/a NEFCOM, ITS Telecommunications Systems, Inc., and Frontier Communications of the South, LLC, for waiver of requirements of Rules 25-4.0185, 25-4.066, 25-4.070, 25-4.073, and 25-4.110(6), Florida Administrative Code, relating to service quality, or in the alternative the waiver of Rule 25-4.073, Florida Administrative Code, relating to answer time requirements, or Rule 25-4.0185, Florida Administrative Code, relating to periodic service quality reporting requirements. These rules relate to quality of service requirements for basic residential customers. This is an amended petition to the petition filed May 13, 2010. The petitioners no longer seek a waiver of Rules 25-4.066, 25-4.070, or 25-4.110(6), Florida Administrative Code.
