Notice is hereby given on July 20, 2010, pursuant to Section 367.045, Florida Statutes and Rule 25-30.030, Florida Administrative Code, of the application of North Peninsula Utilities Corporation, P.O. Box 2803, Ormond Beach Florida 32175, of its intent to apply to the Florida Public Service Commission to enlarge its service area to include the property described below in Volusia County, Florida.

TOWNSHIP 13 SOUTH, RANGE 32 EAST

Section 21

PART OF THE NORTHERLY 176 FEET, AS MEASURED AT RIGHT ANGLES OF THE SOUTHERLY ½ OF LOTS 1 AND 2, SECTION 21, TOWNSHIP 13 SOUTH, RANGE 32 EAST, AS LAYS WESTERLY OF JOHN ANDERSON HIGHWAY, IN VOLUSIA COUNTY, FLORIDA BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
