**PROGRESS ENERGY FLORIDA'S NOTICE OF PARTIAL WITHDRAWAL OF AND
MODIFICATION TO ITS REQUEST FOR CONFIDENTIAL CLASSIFICATION
REGARDING THE ANNUAL STATUS REPORT**

Progress Energy Florida, Inc., ("PEF" or the "Company"), files its notice of partial withdrawal of its Request for Confidential Classification Regarding the Annual Status Report (the "Request"), filed with the Commission on May 3, 2010 and states:

Upon further review, and in consideration of the passage of time, PEF agrees to partially withdraw its Request as it pertains to the information contained in the row titled "Totals (Note 2)" and not to seek confidential classification of that information as originally contemplated by the Request. The Company maintains its claim of confidentiality of other portions of that document (DN 03650-10), as represented in the redacted version of that document attached hereto as Exhibit A. PEF reiterates its request for confidential classification regarding the remaining information originally covered by the Request and nothing contained in this partial withdrawal should be construed as waiving the Company's right to seek the continued confidentiality of that information. It is PEF's understanding that this agreement resolves any


