Case Background

Based on customer testimony at a customer service hearing in Florida Power & Light Company's (FPL or Company) last rate case, the Commission expressed concerns about the relationship between FPL and FPL Energy Services (FPLES), an affiliated company. The issue of affiliate transactions was also raised in the direct testimony of Office of Public Counsel witness Kimberly Dismukes.¹ In the rate case, affiliate transactions were addressed generally in
