SUPPLEMENTAL DOCUMENTATION RELATED TO
ITS REQUEST FOR CONFIDENTIAL CLASSIFICATION OF
INFORMATION PROVIDED IN RESPONSE TO STAFF'S AUDIT REQUEST #2

WATER MANAGEMENT SERVICES, INC. ("WMSI") hereby files supplemental documentation related to its request to the Public Service Commission ("Commission") on July 7, 2010, for confidential classification of information related to a 2008 litigation settlement between WMSI and McWane, Inc., Consolidated Pipe & Supply Company, Inc., Boh Brothers Construction Co., LLC, and Blankenship Contracting, Inc. As part of its request for confidential classification, WMSI provided a copy of the settlement agreement in limited redacted form to the Commission. At the direction of Commission legal staff and in accordance with Rule 25-22.006(4), Florida Administrative Code ("F.A.C."), WMSI hereby provides an unredacted copy of the agreement to the Commission, under claim of confidentiality. Regarding the supplemental documentation related to its request for confidentiality, WMSI states:

1. WMSI's Request for Confidential Classification of Information Provided in Response to Staff's Audit Request #2 ("Request for Confidential Classification"), filed with the Commission on July 7, 2010, remains in effect, including Attachment B, except that the previously provided confidential document, which is identified in the docket as Commission


2. The settlement agreement information subject to WMSI's request for confidentiality fits the statutory definition of propriety confidential business information under Section 367.156(3), Florida Statutes, and Rule 25-22.006, F.A.C., as outlined in WMSI's Request for Confidential Classification, and that information should be afforded confidential classification.

3. WMSI has provided a separate, sealed envelope, containing the mediation settlement agreement dated May 15, 2008, with the appropriate lines containing confidential information highlighted, which is marked as Confidential Attachment A. All of the highlighted confidential information is treated by WMSI as private and should not be disclosed. **This document replaces the confidential document previously provided to the Commission on July 7, 2010, which contained limited redaction (and which is identified as Commission Document #05550-10.)** The highlighted information contained in Confidential Attachment A should be afforded confidential treatment pending a decision on WMSI's request by the Commission.

4. WMSI has not provided another attachment with the redacted, public version of Confidential Attachment A, because the public version of the document remains unchanged from WMSI's July 7, 2010 filing. See Commission Document #05551-10.

WHEREFORE, WMSI requests that the specified confidential information in the mediation settlement agreement highlighted in Confidential Attachment A be classified as confidential and exempt from Chapter 119, Florida Statutes, and Article I, Section 24 of the Florida Constitution for the maximum period allowable.


