At the Commission Conference on October 12, 2010, Commissioners will consider staff's recommendation for Docket 100155-EG, FPL's DSM Plan. The recommendation was filed on September 1, 2010, and has not been revised.

To maintain consistency with the votes at the September 14, 2010, Commission Conference, Commissioners may wish to take the following action on the FPL Demand-Side Management (DSM) Plan:

- 1. Approve the staff recommendation on Issue 1 with the modification that the compliance filing shall also include savings associated with FPL's solar pilot programs;
- 2. Deny the staff recommendation on Issue 2, and direct FPL to file specific program modifications or additions that are needed in order for the 2010 DSM Plan to be in compliance with Order No. PSC-09-0855-FOF-EG within 30 days of the Commission's order;
- 3. Approve the staff recommendation on Issue 3, and direct staff to conduct a workshop to address how the distribution of funds should be allocated;
- 4. Issue 4 would be moot; and
- 5. Approve the staff recommendation on Issue 5 that the docket remain open.
