St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Prehearing Statements for the hearing scheduled to commence in the proceeding November 1, 2010.

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve month period ending December 31, 2010 including interest, the projected conservation program expenses for the twelve month period ending Dec 31, 2011 and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve month period ending December 31, 2011 as filed by SJNG.

D. SJNG's position on each issue:

1. What are the final conservation cost recovery true-up amounts for the period January 2009 through December 2009?

SJNG: An under-recovery of \$122,530.00

2. What are the actual/estimated conservation cost recovery true-up amounts for the period January 2010 through December 2010?

SJNG: An underrecovery of \$76,759.

3. What are the total conservation cost recovery amounts to be collected during the period January 2011 through December 2011?

SJNG: Total conservation cost recovery is \$186.834.

4. What is the appropriate Conservation Cost Recovery Factor to be applied to customer bills during the twelve month period ending December 31, 2011?

SJNG: \$0.32519 per therm for RS-1, \$0.20316 per therm for RS-2, \$.15080 per therm for RS-3, \$.13359 per therm for GS-1, \$.06978 per therm for GS-2, and \$.03189 per therm for FTS-4.

5. What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG: The effective date should be January 1, 2011.
