Dear Ms. Cole:

I have enclosed a document prepared by our office which compares the current rates charged by Aqua Utilities Florida, Inc., to the statewide uniform rates proposed by the company in Docket 100330-WS.

We are filing this document because we have received a complaint that the notice provided by the company is inadequate and misleading. First, the notice does not disclose the current rates paid by customers, so there is no benchmark for customers to compare the proposed rates against existing rates. Without this benchmark a customer does not know the percent by which the company proposes to increase rates in this case. Second, the notice does not state that the gallonage charge proposed by the company is the rate *per 1000 gallons*. The notice, for example, states that the water gallonage charge in block 1 (0-6000 gallons) is \$6.49. This would lead a customer to incorrectly believe that the total gallonage charge for up to 6000 gallons of use is \$6.49.
