### **Dates**

- When writing out complete dates (month, day, year), put a comma after the day and year.

The Commission approved the rate change on December 1, 2000, for the utility.

The soldier was born on June 5, 1920, and enlisted in the army before WWII.

- **Exception:** When the complete date functions as an adjective to a noun that follows

immediately, omit the comma after the year.
