NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that Verizon Florida LLC's petition for waiver of Rule 25-4.040(2), Florida Administrative Code, filed June 14, 2010, in Docket No. 100327-TL was denied by the Commission by Order No. PSC-10-0599-PAA-TL, issued September 30, 2010, consummated by Order No. PSC-10-0635-CO-TL, issued October 25, 2010. The rule addresses the requirement of a local exchange company to furnish one copy of the residential listings section of the telephone directory to its subscribers on an up front basis. The petition was denied; however, a temporary rule waiver for a period of two (2) years was granted. The Commission found that the waiver request recognized advances in technology while protecting the interests of subscribers who want to continue to receive a free printed residential white pages directory. The Commission granted a temporary rule waiver to allow Verizon Florida LLC and Commission staff an opportunity to solicit feedback from Florida consumers to determine how they feel about the discontinuance of an up-front copy of the residential white pages directory. Notice of the petition was published in the FAW on July 2, 2010.
