5. Please provide copies of any and all reports or reviews for Aqua Utilities Florida, Inc. prepared by or for rating agencies (Standard & Poor's Rating Service, Moody's Investor Service and Fitch Ratings) since January 1, 2009.
6. Please provide Schedule D-1 and Schedule D-2 for all systems in a spreadsheet format with all formulas intact including the revisions to these schedules.


