I used "O&S" in the recommendation for Dkt. No. 100440-WU based on its use in the recommendation for Dkt. No. 100400-WU and in MCD. The company's filings in Dkt. No. 100400-WU in CMS state the name as "O&S" (for example, Document Nos. 08025-10 and 09339-10). It wasn't until the company submitted filings in Dkt. No. 100440-WU that it started using "O & S."

It seems to me that it would be okay to change the name to "O&S" in CMS in order to make it match the recommendations, MCD, and the company's filings in the earlier docket, Dkt. No. 100400-WU.
