Re: Docket No. 100435-EG - Petition for approval of extending the small general service price responsive load management program pilot, by Tampa Electric Company.

By this letter, the Commission staff requests that Tampa Electric Company (TECO) provide responses to the following data requests.

Please answer the following questions regarding Tampa Electric Company (TECO).

1. In Order No # PSC-09-0501-TRG-EG, issued July 15, 2009 in Docket No. 090228-EG, the pilot program is funded through the Conservation Research and Development Program, which in turn is funded through the ECRC in an amount up to \$500,000 for a period of 5 years through 2010. Please explain and justify the difference in funding.
2. Please provide the total amount for maximum expenditures for the pilot Small GS Price Responsive Load Management program that was originally established.
3. Please provide the total amount for total expenditures to date.
4. Please provide the total amount for maximum expenditures if the extension through June 30, 2011 is granted.
5. The petition states that "due to the timing of installations, Tampa Electric was unable to fully evaluate winter demand reductions." Please explain or describe the installations and the reasons for the delays.
6. Please provide the figures comparing the percent increase in expenditures to the percent increase in time if the extension is granted.
