On behalf of A.R.C. Networks, Inc. d/b/a InfoHighway ("A.R.C."), please be advised that A.R.C. intends to discontinue the offering of competitive local exchange and interexchange telecommunications services within the State of Florida effective December 31, 2010.

A.R.C. was granted Certificates of Public Convenience and Necessity to provide competitive local exchange telecommunications services in Certificate Proceeding 4740 and interexchange telecommunications services in Certificate Proceeding 4720. A.R.C. respectfully requests that the Commission cancel these Certificates as of December 31, 2010. A.R.C. also requests the withdrawal of its associated competitive local exchange and interexchange telecommunications services tariffs on the same date.

A.R.C. presently has no local or interexchange telecommunications services customers in Florida; accordingly, there are no customers upon whom notice of cessation of service may be served. Furthermore, A.R.C. has satisfied its annual regulatory assessment fee for 2010 and is current with all reports and other filings required by the Commission.
