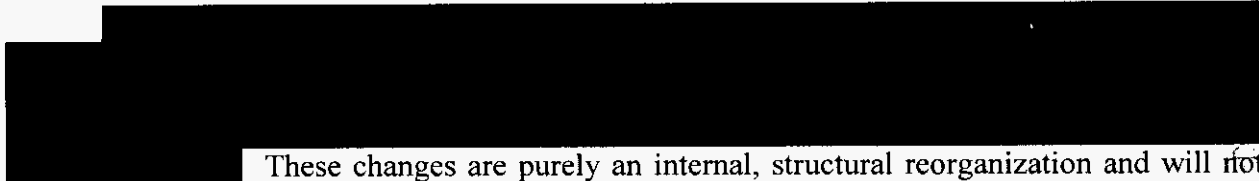

I am writing to you to update the Commission on some upcoming changes in the organizational structure of the companies of Cox Communications, Inc., the parent company of Cox Florida Telcom, L.P. As you know, Cox Florida Telcom operates as both a registered IXC (TK015) and a certificated CLEC (Certificate 4036) in Florida. The following information is being provided under the cover of a confidential claim in accordance with Rule 25-22.006(5), Florida Administrative Code, and we ask that the highlighted information contained herein and in the referenced attachment be treated as confidential. In accordance with the Rule, I am also including 2 redacted copies of this letter and the attachment. The redacted information is treated by Cox as confidential and has not otherwise been released.



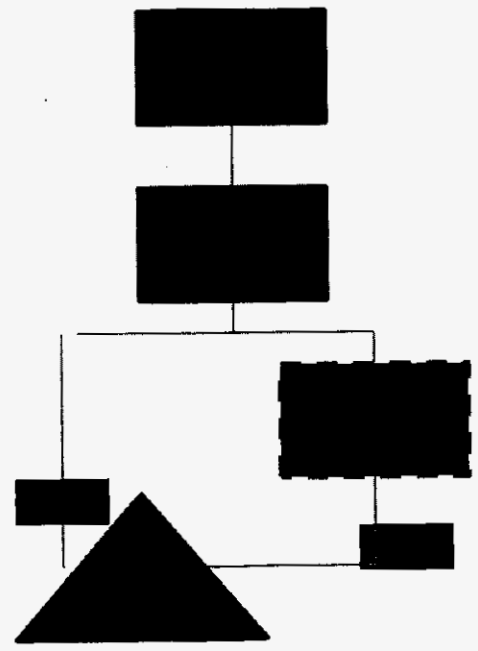
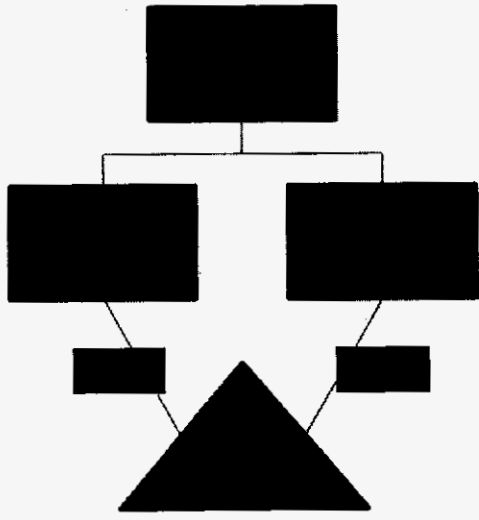
