**SECTION 63.71 APPLICATION**

Mosaic Telecommunications LLC ("Mosaic"), pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, hereby files this application to discontinue the provision of domestic and international switchless long distance services in Michigan, Texas, and Florida. In support of this Application, Mosaic submits the following information:

**I. Description of Discontinuance**

**1. Name and address of carrier:**

Mosaic Telecommunications LLC.

Grosse Pointe Park, MI 48230

**2. Date of planned service discontinuance**

Mosaic ceased all long-distance resale operations on or before 6/30/2009.

**3. Points of geographic areas of service affected**

There are no geographic areas that will be affected by this discontinuance, as the company has not provided any service for 17 months. Mosaic held tariffs in Michigan, Texas, and Florida.

**4. Brief description of the type of service affected**

Mosaic discontinued all long-distance resale on or before 6/30/09. Mosaic is a switchless reseller of long-distance service.

**5. Brief description of the dates and methods of notice to all affected customers**

Every Mosaic customer was advised by telephone call of Mosaic's intention to discontinue all services in May 2009. Mosaic does not have any current customers, and therefore has not created a written notice to customers.

**6. Non-dominance of the carrier with respect to the service to be discontinued**

Mosaic is non-dominant with respect to the service that it proposes to discontinue.

**7. Service**

In accordance with Section 63.71 of the Commission's rules, Mosaic has mailed a copy of this application to the Michigan Governor, the Michigan Public Service Commission, the Texas Governor, the Texas PSC, the Florida Governor, the Florida PSC, and the Secretary of Defense.

**8. Additional questions regarding this application may be addressed to the undersigned.**

**II. Circumstances of Discontinuance**

Mosaic has determined to revise its business plan and to discontinue the provision of service, including switchless domestic and international long distance telecommunications resale services.

Mosaic's discontinuance of services to customers, while regrettable, is necessary and appropriate, and will not adversely affect the public convenience and necessity. The public will not be unduly harmed by Mosaic's discontinuance of the telecommunications service described above because customers have been given notice that affords them an ample opportunity to transfer to a new carrier. Mosaic has provided the minimum 30-day notice required by the Commission for discontinuance of domestic and international services.

**III. Conclusion**

Mosaic believes that the proposed discontinuance is reasonable and necessary. As outlined herein, Mosaic has taken take all reasonable steps, to the extent it is able, to assure that the discontinuance of service is not unduly disruptive to the present or future public convenience and necessity. Accordingly, Mosaic respectfully requests that the Commission permit it to discontinue the provision of services to customers in Michigan, Texas, and Florida pursuant to Section 63.71.


