Pursuant to Rule 25-6.0143(1)(l), F.A.C., each utility is required to file a Storm Damage Self-Insurance Reserve Study ("Study") with the Commission Clerk by January 15, 2011 and at least once every five (5) years thereafter. Progress Energy Florida, Inc. ("PEF") has already met this requirement when we filed our Storm Damage Self-Insurance Reserve Study in our 2009 Rate Case in Docket No. 090079-EI. Based on this fact, PEF will not be filing another Study on January 15, 2011. In accordance with the Rule, PEF will file its next Study in March 2014 or in our next base rate proceeding.
