**RE:** Closure of Docket 100335-TX; Request for waiver of carrier selection requirements of Rule 25-4.118, F.A.C., due to the transfer of customers from Global Crossing Telemanagement, Inc. to Global Crossing Local Services, Inc.

On June 22, 2010, Global Crossing Telemanagement, Inc. (GCTM) and Global Crossing Local Services, Inc. (GCLS) filed a joint petition for a waiver of the carrier selection requirements of Rule 25-4.118, Florida Administrative Code (F.A.C.), in order to facilitate the transfer of customers from GCTM to GCLS due to the merger of the two companies. By Order No. PSC-10-0453-PAA-TX, issued July 15, 2010, the Commission approved the companies' joint petition for a waiver. The Commission further ordered the parties to notify the Commission when the merger was complete. On January 5, 2011, the parties notified the Commission that the merger was completed as of December 31, 2010.

The parties have complied with the provisions of Order No. PSC-10-0453-PAA-TX; therefore, this docket should be closed administratively.
