

If I have an opportunity to speak at agenda, I will share your comment below. You had made this point in your letter to the Commission Clerk and that letter is contained in the docket file.

We do not view consent orders as negative. A consent order is a tool used to arrive at a settlement agreement agreed upon by the DEP and a utility that recognizes items to be altered, added, or modified to comply with DEP rules or to improve the operation of the plant and system. The goal of a consent order is to resolve issues through an agreed upon settlement document, setting forth dates certain for resolution. It is not unusual for a water or wastewater company to sign a consent order with the DEP.


