

## Issue 1:

1. Please refer to both AT&T's and STS' November 17, 2010 responses to staff's data request. STS states in its response that it can order a UNE SL2 DS0 commingled with a request "B" through the LEX ordering interface. However, on page 12 of STS' response, STS notes that a fictitious NCI code is populated in LEX when ordering a UNE SL2 DSO commingled arrangement with a request type "B" (the correct NCI code is subsequently noted in the "remarks" field in LEX as special handling). STS can populate the correct NCI code in LEX when ordering a UNE SL2 DSO commingled arrangement with a request type "A". Please explain why the NCI code that is used in the request type "A" commingled arrangement, or one of the three valid NCI codes, cannot be used in a request type "B" commingled arrangement.

Response: Req Type B commingled with Special access exceptions to the LSC for manual handing. Service Representatives have been trained to review STS' LSRs for both the NCI field and RMKS field. If the RMKS field is populated with 04QB9.11, 04QB6.S1 or 04QB6.33 the Service Representative will recognize that STS is ordering Req Type B with Commingling. Populating the NCI field with 04QB9.11, 04QB6.S1 or 04QB6.33 is not recommended and may cause additional confusion with downstream databases resulting in potential FOC or due date delays. Additional coding would be required to support the entries of 04QB9.11, 04QB6.S1 or 04QB6.33 in the NCI field.

2. With the exception of STS, how many other CLECs in Florida and in AT&T's southeast region currently order UNE SL2 DS0 commingled arrangements through LEX using one or more of the three valid NCI codes?

**Response:** No other CLECs have requested Req Type B commingled with Special Access, regardless of application. Additional coding would be required to support the entries of 04QB9.11, 04QB6.S1 or 04QB6.33 in the NCI field and would only satisfy STS' demand to dictate how AT&T develops its applications and business rules. Proprietary] It should further be noted that AT&T published the CLEC Information Package "Migrations to Commingled UVL-SL2 Loop with Number Portability" over 8 months ago (April 26, 2010)

## Issue 3:

3. Would AT&T be amenable to providing the existing R/C/O tables in a Microsoft Word format to CLECs if **AT&T** is to be responsible for making the changes to the Word document to keep it up to date? If not, please explain. Additionally, as noted on page 20 of STS' response, please explain how a CLEC would be able to navigate the 1,707 page document without index tabs.

**Response:** No, AT&T will not continue to maintain the R/C/O tables. AT&T provided interested CLECs with the R/C/O file in Microsoft Word format. If requested, AT&T will also provide a .pdf file of the R/C/O data so that a CLEC can review the .pdf file and add tabs to the

Microsoft Word file. In addition AT&T will make the R/C/O file available to interested CLECs in a .pdf format which supports bookmark. As previously stated, AT&T has already offered the R/C/O file in Microsoft Word format and, while some CLECs requested the file, STS did not.
