

**SECTION 63.71 APPLICATION OF
SMART CITY TELECOMMUNICATIONS, LLC**

Smart City Telecommunications LLC (“Smart City” or “Applicant”), through its undersigned counsel and pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.71 of the Commission’s rules, 47 C.F.R. § 63.71, hereby files this application to discontinue the provision of Cable Television Transport Service (“CTT Service”) in Celebration, Florida.

As described in greater detail below, Smart City’s CTT Service has no current customers, and discontinuation of service will not impact any end user. The sole prior customer for CTT Service, Comcast of Celebration, LLC (“Comcast” or “Customer”), has elected to transition to a different service under a private carriage arrangement that became effective January 1, 2011.

As required by Section 63.71(a) and (b) of the Commission’s rules, Smart City provides the following information:

I. Description of Discontinuance

1. Name and address of carrier

2. Date of planned service discontinuance

There are no current customers for CTT Service. Applicant will formally discontinue CTT Service and cancel the underlying tariff upon receipt of Commission authorization under Section 63.71.

3. Points of geographic areas of service affected

The discontinuance of service will affect Celebration, a master-planned, unincorporated town in Osceola, Florida 34747.

4. Brief description of the type of service affected

CTT Service uses Smart City fiber and coaxial cable facilities as the transmission medium for the delivery of Customer provided cable television and complementary services to individual business and residential end users.

5. Brief description of the dates and methods of notice to all affected customers

Written notice to the Customer was mailed on January 21, 2011. Attached as Exhibit A is a copy of the customer notice letter.

6. Dominance of the carrier with respect to the service to be discontinued

Smart City is dominant with respect to the service that it proposes to discontinue.

7. Service

In accordance with Section 63.71 of the Commission's rules, Smart City has mailed a copy of this application to the Florida Governor, the Florida Public Service Commission and the Special Assistant for Telecommunications for the Secretary of Defense.


II. Circumstances of Discontinuance

Comcast, which has authority to deliver cable television and complementary services to Celebration, has used Smart City fiber and coaxial facilities for the transmission of its services to business and residential customers since June 16, 1996, pursuant to Applicant's Cable Television Transport Service Tariff FCC No. 2. Comcast and Smart City have entered into a new private carriage relationship effective January 1, 2011, and Comcast consented to the termination of CTT Service under the Tariff. Given that tariffed CTT Service is no longer required by the sole prior customer, Smart City seeks to formally discontinue service pursuant Section 63.71 of the Commission's rules. Pursuant to Sections 61.20 and 61.87 of the Commission's rules, Smart City will cancel Tariff No. 2 in its entirety after receiving approval of discontinuation from the Commission.

III. Conclusion

As described above, the discontinuance of service will not impact any Smart City customer or harm the public interest. Accordingly, Smart City respectfully requests that the Commission approve this application pursuant to Section 63.71.

Re: Cable Television Transport Service Tariff

Dear Mr. Russell:

Effective January 1, 2011, Smart City Telecommunications LLC ("Smart City") fiber and coaxial cable distribution facilities are provided to Comcast of Celebration, LLC ("Comcast") (Smart City and Comcast jointly referred to hereafter as the "Parties") pursuant to an Agreement for Signal Carriage ("Agreement") between the Parties. As contemplated by the Agreement, Smart City will file with the FCC an application for the discontinuation of Cable Television Transport Service ("CTT Service") previously provided under Tariff F.C.C. No. 2 on January 24, 2011, pursuant to Section 63.71 of the FCC's rules. Under this rule, we are required to notify Comcast of the impending discontinuation of tariffed service.

The FCC will normally authorize this proposed discontinuance of service (or reduction or impairment) unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 30 days after the Commission releases public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of Smart City Telecommunications LLC. Comments should include specific information about the impact of this proposed discontinuance (or reduction or impairment) upon you or your company, including any inability to acquire reasonable substitute service.
