Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Progress Energy Florida requests confidential classification of certain highlighted information provided in Exhibit WG-3T (info in Schedule A12), attached to the Direct Testimony of Will Garrett, filed 3/1/2011.
