NOTICE OF OBJECTION

(pursuant to Rule 25-30.03,
Florida Administrative Code.)


I, James I. Minnes am a customer of Service Management Systems, Inc. and do hereby, object to the Application for Transfer of Majority Organizational Control of Service Management Systems, Inc. (hereinafter referred to as " the utility") from the utility to Aquarina Utility Inc. on the following grounds:

- 1) The transfer is contrary to Rule 25-30.037(3)(f), Florida Administrative Code. The application for approval of the transfer is not in the public interest by reason of the following:
 - a) The interest of Aquarina Utilities Inc. is substantially and materially different than all prior operators of the Utility and is contrary to the interests of the customers being served by the Utility.
 - b) Aquarina Utilities Inc. through its principal Directors, Officers and shareholders has not demonstrated competence, responsibility and ability in past water and waste water operations in the Counties of Brevard, Martin and Polk, Florida.
 - c) Aquarina Utilities Inc. has not demonstrated that it has the financial ability or the resources to :
 - (i) Fund the capital needs of the Utility,
 - (ii) Provide real and substantial benefits to the customers of the utility as capital and/or operational needs demand,
 - (iii) Guarantee continuous and adequate water and waste water services in a safe and healthful manner to its customers.
- 2) The Application is materially deficient in failing to include the information required pursuant to the following Rules of Florida Administrative Code;
 - i) Rule 25-30.037(c), the names and addresses of all Aquarina Utilities Inc. corporate officers, directors, partners and any other persons who own and interest in the utility.
 - ii) Rule 25-30.037(e), a statement describing the financing of the purchase and the financial status of the purchaser, its shareholders and principals.

(iii) Rule 25-30.037(g), a list of all entities including affiliates that have provided or will provide funding to Aquarina Utility Inc. and an explanation of the manner and amount of such funding,

iv) Rule 25-30.37(h), a statement that the system is in need of repairs or improvements with a list of the repairs and improvements needed and the approximate cost to make them.
